The School of Canon Law at The Catholic University of America announces an INSTITUTE ON MATRIMONIAL TRIBUNAL PRACTICE to be held on the University campus at Theological College, **June 20 - July 1 2022**. This program is designed for clergy, religious and laypersons who have not had formal training in canon law.

The Institute provides an overview of the history and the Church's teaching on marriage, an introduction to the Church's marriage law, and an explanation of the process and jurisprudence that apply to marriage nullity trials carried out in Church Tribunals today. In addition, case study sessions add a practical dimension to the program.

The Institute continues a tradition begun in 1967. Institute participants have included those involved in parish ministry and various kinds of tribunal work, as well as others interested in the subject matter.

Space is limited. Applicants are accepted on a first-come, first-serve basis. Admission is not completed until both the application and Institute fee have been received.
